- (i) The condition is irreversible and incurable; and
- (ii) In accordance with medical standards and a reasonable degree of medical certainty, based on an individual assessment of the inmate, the condition is likely to cause death to the inmate within 18 months.

Medically Incapacitated: That an individual has any diagnosable medical condition, including dementia and severe, permanent medical or cognitive disability, that prevents the individual from completing more than one activity of daily living without assistance or that incapacitates the individual to the extent that institutional confinement does not offer additional restrictions, and that the condition is unlikely to improve noticeably in the future.

- Get into/out of bed or chair
- Toilet hygiene

Dear Board Members,

The Sangamon County State's Attorney's Office OPPOSES Sean Grayson's request for compassionate release. For the reasons stated herein, the Board should DENY his request for compassionate release.

On July 6, 2024, Grayson, then employed as a Sangamon County Sheriff's Deputy, was dispatched to [REDACTED] in Springfield for the report of a prowler. Sonya Massey opens the door to her residence and tells Grayson that she believes someone is outside her house. Grayson ultimately enters Ms. Massey's home. While inside the home, Ms. Massey removes a pot of water from her stove in her kitchen. Grayson laughs. Ms. Massey asks: "where are you going?" The Defendant laughs and says he is "getting away from your hot steaming water." Ms. Massey responds: "Away from my hot steaming water? I rebuke you in the name of Jesus." The Defendant responds: "Huh?" Sonya Massey repeats: "I rebuke you in the name of Jesus." The Defendant escalates this encounter by yelling: "you better fucking not or I swear to God I will shoot you right in the fucking face." He then draws his service weapon and points it at Ms. Massey. At this time, Grayson is in the living room of the home while Ms. Massey is standing in the kitchen. Ms. Massey is several feet away and is separated from Grayson by a kitchen island. Ms. Massey proclaims that she is "sorry" and drops to the floor. Grayson approaches Ms. Massey and ultimately discharges his weapon three times. Ms. Massey is struck by one of the bullets and collapses to her kitchen floor. She is audibly gasping for air and bleeding. Grayson discourages the other deputy on the scene, Deputy Farley, from getting a medical kit or rendering aid. He tells Deputy Farley: "it's a head shot dude. She's done. You can go get it. But that's a headshot. ... [L]et her fucking... just. There is nothing we can do, man." Eventually, Grayson leaves to retrieve a medical kit from his squad car. When he finally returns

with his medical kit, he asks a supervisor whether there is “anything you think we could do for her?” When the supervisor responds in the negative, Grayson throws his medical kit on the ground and says: “I’m not going to even waste my med stuff then.” At this time, Deputy Farley is applying pressure to Ms. Massey’s wounds with dish towels. Deputy Farley could have used the medical kit to possibly stop the bleeding. Indeed, at trial, Dr. Nathaniel Patterson testified that Sonya Massey’s wound was not necessarily fatal and that she could have lived if the bleeding was controlled. Grayson then exits the residence and tells another officer that “this fucking bitch is crazy.”¹ At the time of the shooting, Grayson had previously been diagnosed with colon cancer. Ms. Massey is later pronounced dead at the hospital.

On October 29, 2025, Grayson was found guilty of second-degree murder in Sangamon County Case No. 24-CF-909. On January 29, 2026, the Honorable Ryan M. Cadagin sentenced Grayson to 20 years in the Illinois Department of Corrections. At sentencing, Grayson’s attorney explicitly referenced the cost of incarceration and his medical condition. Indeed, Grayson’s attorney argued for a lesser sentence because his colon cancer had spread to his liver, resulting in Stage IV liver cancer, as well as to his lungs. The Court ultimately determined that a sentence of 20 years in prison was appropriate.

Following his sentencing hearing, Grayson filed a *pro se* application for compassionate release under the Joe Coleman Act. *See* 730 ILCS 5/3-3-14(c). Under the Act, an inmate suffering from a terminal illness or medical incapacity may be released early from prison and released on parole. *Id.* § 5/3-3-14(g).

When considering an application for compassionate release, the Board may consider:

- (i) the petitioner’s diagnosis and likelihood of recovery;
- (ii) the approximate cost of health care to the State should the petitioner remain in custody;
- (iii) the impact that the petitioner’s continued incarceration may have on the provision of medical care within the Department;
- (iv) the present likelihood of and ability to pose a substantial danger to the physical safety of a specifically identifiable person or persons;
- (v) any statements by the victim regarding release; and
- (vi) whether the petitioner’s condition was explicitly disclosed to the original sentencing judge and taken into account at the time of sentencing.

Id. § 5/3-3-14(f).

Turning to these factors, Grayson remains a substantial danger to the physical safety of the community and any person he may contact. *Id.* § 5/3-3-14(f)(iv). He was already diagnosed with cancer when he shot and killed Sonya Massey in her kitchen. His temper and willingness to escalate minor misunderstandings into fatal encounters shows that he poses a danger to any person he comes into contact with. Cancer does not make him less dangerous.

¹ The murder of Sonya Massey is captured on Deputy Farley’s body-worn camera. Grayson did not turn on his body-worn camera until after the shooting, but his camera still captured the fatal moment due to an automatic recording feature. These videos provide a unique opportunity for the Board to review the commission of this offense. This Office can provide a copy of these videos to the Board, upon request, but they have also been widely disseminated in the media.

The Board should also consider the statements made by the victims. *Id.* § 5/3-3-14(f)(v). The family of Sonya Massey strongly opposes release.

Critically, Grayson's medical condition was explicitly disclosed to the Court at sentencing. *Id.* § 5/3-3-14(f)(vi). Grayson's medical condition and the cost of incarceration were considered—and rejected—by the sentencing judge.

Ultimately, the Board should DENY Grayson's request for compassionate release. He shot and killed an unarmed woman in her home. He refused to provide medical care and discouraged another deputy from providing medical care. He has literally *just* begun his 20-year sentence for second-degree murder. Critically, Grayson had cancer when he committed this murder and his medical condition was explicitly considered at sentencing. To release Grayson under these circumstances would be a miscarriage of justice and an insult to Sonya Massey's memory and family.

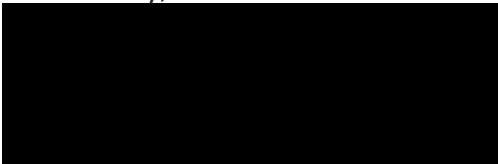
